## Chairman's Report New Councillors

We hope you will join us in welcoming our new Parish Councillors. Cllrs Neil Beckham, Paul Morgan, David Roberts and Sara Lord have been co-opted onto the Parish Council. There is one further vacancy to fill due to the resignation of Cllr David Craggs, which we hope will be filled at our February Meeting.

The Parish Council would like to thank David for 13 years of dedicated service and appreciates his offer to allow another new person to gain experience with the Council before the elections in May.

#### Council Tax 2019-2020

Goostrey Parish Council has set the budget it believes it needs to fulfil its responsibilities in 2019-20 whilst retaining sufficient reserves to cope with unexpected expenditure. The budget is set to stay the same as last year. The number of Goostrey properties has increased slightly, so each household will see a small decrease in the Parish Council element of their Council Tax. Cheshire East Borough Council will not decide its own final budget and Council Tax until its meeting on 21st February 2019, however its pre-budget consultation states that "proposals include the option to increase Council Tax by up to 2.99%. The Medium Term Financial Strategy presented to Council in February 2018 included a 1.99% increase, and an additional 1% is now included to mitigate ongoing pressures in Children and Families Services. This approach would add approximately 80p per week to the average household Council Tax hill"

## Planning - Sibelco Silica Sand Quarry

Although none of the proposed site in the Sibelco planning application for a new quarry is in Goostrey (it is entirely within Cranage and Allostock Parishes), Goostrey Parish Council did submit an objection.

The Cheshire East Strategic Planning Board have subsequently approved the application subject to planning conditions, including highways improvements at the A50 and a ban on any lorry traffic passing through Goostrey (which has a 7.5te weight limit throughout the villare).

In January, Cheshire West also approved the application. However Cheshire East now have to consider new representations and subsequently the Secretary of State, Rt Hon James Brokenshire MP, will decide whether or not to 'call-in' the application for his own determination.

# Highways and SpeedWatch Goostrey Station Bridge

Cheshire East Highways have informed us that the scheme to install a safe area for pedestrians to cross the Station Bridge and traffic lights is on hold. We received the following explanation directly from Cheshire East Highways last week.

"The scheme was programmed in to commence on site in March 2019, however after meeting with the Contractors on site to discuss the buildability aspects of the scheme, it became apparent that it would not be possible to implement the scheme as per the original design. This is mainly down to the complexities of the site in terms of the highway boundary extents.

We have therefore had no option but to place the scheme on hold while we investigate other options in order to ensure that we design and deliver a workable solution that is safe for all road users.

I appreciate this is not the news you wanted to hear, however I can assure you that we are working hard to explore other options to enable the scheme to be constructed".

We are extremely disappointed with this new delay, however, we are in contact with Cheshire East Highways and have been assured that finding a "buildable" scheme is a priority for them.

#### Parish Council Opportunity

In April this year we will come to the end of the 4 year term of office for all Parish Councillors. All ten positions will become vacant at this time. Anyone who lives in Goostrey Parish, or nearby, can put themselves forward for election in May as a Councillor (see item below). This is an opportunity to contribute to village life in different ways and past councillors have found it both worthwhile and satisfying. You can find out more about what the Parish Council does by coming to the Annual Parish Meeting on Monday 18th March which is open to all. If you have some time to offer and would like to see Goostrey maintained and improved, I also encourage you to apply.

# Town & Parish Council Elections 2nd May 2019

Anyone who has an interest in becoming a Councillor can contact one of the existing Councillors or the Clerk to find out what being a Councillor involves.

The Clerk will be taking delivery of candidate forms and information packs in February and once the application date is announced we will post the information on how to obtain a form on the Parish Council Notice boards and the web site.

#### Speed Watch

Our dedicated SpeedWatch volunteers have carried out SpeedWatch sessions most weeks in the winter months at the various approved locations in the village.

PCSO Liz Chesters joins the team when she is able, and the log sheets are sent to her within a few days of the session so that she can action any letters for motorists travelling at 36 mph and above.

We have also learned from the Police that a house visit it made to anyone travelling at 50 mph and above to highlight the severity of travelling at such speeds in a 30 mph speed limit area..

We are currently arranging more SpeedWatch sessions for our volunteers in the coming months.

# Booth Bed Lane & Hermitage Lane

The Parish Council has been working with CEC Highways to find ways to improve the safety of the Booth Bed Lane/Hermitage Lane Junction. There is very restricted space for changes, however it has been agreed that the signage on all approaches will be improved, as most accidents arise from speeding and/or lack of awareness of the junction. The Parish Council would like to thank our Ward Councillors Les Gilbert and Andrew Kolker for obtaining the funding and it is hoped the improvements will be carried out by the end of March

#### Village Hall Supervisor

Our Village Hall Supervisor, Janet Keates, joined us on 7th January. She has taken over responsibility for bookings, caretaking and customer cervices at the Village Hall.

#### Village Hall Team

Janet has a wealth of experience in customer services, buildings management and caretaking, and we are happy to welcome her to the team.

Assisting Janet will be our dedicated cleaner, Sue Sproson, who manages housekeeping and Sharon Jones will continue to raise invoices and take payments for events at the Village Hall.

#### **Bookings**

This means that it is updated very soon after a provisional booking is made by phone. A new booking form is available on our website and we also have copies in the entrance hall at the Village Hall. #### Electronic Entry to the Village Hall & CCTV

We have just installed a new door entry system for the Village Hall, this system, together with CCTV cameras directed at the front entrance and the kitchen entrance will ensure that the building is secured after each event.

We have privacy filters applied to the CCTV camera in the lounge which allows us to see the back door and the tops of the windows but screens out the main part of the room to protect hirer's privacy during events.

Janet is starting to phase in the use of the electronic entry systems with our regular hirers and will meet with each group to explain how it works before they use it for themselves.

Choose the type of fault you want to log in the "Report IT" section.

You will be asked to complete the form giving the location of the fault and a description of the fault.

Please note that if the door on the lamp post is open or has been removed it will make the issue a high priority fix.

If the fault is not fixed within 14 days please call Cheshire East Faults to chase it up or send the fault reference to the Parish Clerk so she can take the matter up with Cheshire East. Highways.
