Council Tax 2020-21

The Parish Council Committees reviewed their budgets identifying any projects/areas requiring increased expenditure. The outcome of this is that we have set the budget we believe fulfils our responsibilities in 2020-21 whilst retaining sufficient reserves to cope with unexpected expenditure. Each committee has identified areas of additional investment, but these are being offset by savings and plans for increased income. In considering the Parish Council's budget it has been decided to keep it the same as 2019/20. The 'Tax Base' (the number of Band D equivalent homes in Goostrey) used to

set wider Council Tax, reduced from 1,086 to 1,082 in December 2019, which means that keeping the Precept the same represents a small increase of 0.3% in Council Tax, despite an increase in Cheshire East's Council Tax of 3.99%. In the autumn of 2020, the Parish Council Committees will once again take a close look at budgets for 2021/22. We would welcome residents' suggestions for areas of investment and improvement within the village (remembering our income from the precept is £44,012).

Goostrey Railway Sidings Update

The Parish Council would like to thank everyone who responded to our letter of 21st January 2020 regarding the possible purchase of the 6.4 acres of railway sidings land at Station Road. We Unfortunately, we have now been sent out 980 letters and although the time to reply was only one week, we received 616 replies before the deadline. This represents 33.3% of the total electorate of Goostrey Parish and is a high return for consultations of this kind.

Analysis of the returns showed 542 votes (88%) in favour of making an offer and 73 votes (12%) against.

The Parish Council had an in-depth discussion on the outcome of the vote and reviewed all the individual comments that were submitted. The benefits and risks were also considered.

Goostrey Annual Parish Meeting

The Parish Council encourages all Goostrey residents to come along to the Annual Parish Meeting which is due to be held on Tuesday, 5th May 2020 at 7.30pm in the Village Hall (this meeting may be postponed due to Coronavirus. Updates will be placed on the notice boards and the web site).

As a result, it was decided to make an offer which was felt to be both realistic and within the financial limit given in the survey letter.

FOGS Members are Celebrating Again!

On Sunday 8th March, between sunshine and showers, FOGS members took time out of their regular monthly working party at Goostrey Station to celebrate.

First they mounted the 2019 Campaigns Award from the Cheshire Best Kept Station competition. This recognises the negotiations over a number of years which resulted in the repair of the Victorian wooden building.



Later a plaque in memory of the late Cyril Caulkin was unveiled by his son Andrew. The plaque reads 'In memory of Cyril Caulkin, founder member of the



Friends of Goostrey Station and member of Goostrey Parish Council, whose vision initiated the restoration of the old ticket office.' It was fitting that Cyril's brother Keith, two of his grandchildren and several friends were able to be there.

Before the unveiling, Cyril's friend Peter Godfrey (former Chairman of Goostrey Parish Council) made a short speech on behalf of FOGS members. He commented that 'Cyril would have loved to see this building so beautifully restored. And he would be delighted that we are still improving our station.'

Highways & SpeedWatch

Rail Incursion Scheme at Goostrey Station Bridge

As you will be aware we have been in discussions with CEC Highways since 2016 about the dangers of a railway incursion by road traffic at Goostrey Railway Bridge, due to the absence of any barriers to prevent vehicles leaving the road and descending directly onto the track. We are also concerned about the safety of pedestrians crossing the bridge from one platform to the other as there is no footway on the bridge.

We have now been informed that although CEC's assessment in 2016 showed that the probability of injury is "high", CEC's contractors (Ringway Jacobs) cannot find a "feasible" solution to the problem and therefore only minor adaptations are proposed (20mph speed limit and cutting back vegetation).

The Parish Council has written to Cllr Crane, CEC who is responsible for road safety to express our frustration and dissatisfaction with the suggested solution and to put forward what we believe is a

"feasible" solution to improve road safety on the bridge.


We will update residents once we have receive a reply from Cllr Crane.

SpeedWatch

The SpeedWatch Team has conducted 22 sessions since the last Newsletter was distributed. A total of 5,876 vehicles have been monitored with 84 vehicles logged at 35mph and above. The highest speed recorded is 44 mph. There has been a reduction in the number of vehicles monitored travelling at 35 mph and above from 1.8% of vehicles monitored 12 months ago to 1.6% of vehicles monitored for the current period. This includes two sessions when no vehicles were recorded travelling at over 35 mph. We hope that this may be indicative of a change in drivers' behaviour in Goostrey with a general reduction in speeding prompted by the SpeedWatch Sessions.
