Dear Ms Bambrook,

I have been asked by the Chief Executive to respond to you on her behalf. I have reviewed your previous correspondence and the responses sent from the Head of Planning. Thank you for taking the time to bring this matter to the Chief Executive's attention. I would reiterate Mr Malcom's apology regarding the error made with the issuing of the planning permission.

In terms of the three points that you raise, I would add to Mr Malcom's comments regarding the rareity of objections from JBO. Revocation of a planning permission is an extremely rare course of action for any Local Panning Authority to take. It must be considered expedient to take that course of action, and also must be noted that a planning permission cannot simply be removed without payment of compensation. It is a complex legal process – potentially requiring approval of the Secretary of State. It is not a route that the Local Planning Authority considers appropriate in this instance.

In terms of the Planning Service, I would take this opportunity to make you aware that the service has recently been through a detailed service review. This has looked at many areas of the service and has resulted in a Modernisation Plan which we are in the process of delivering. This will result in a number of changes in the service in terms of processes and workflow and we are confident that this is resulting in positive changes in service delivery. In addition, application processes are also being reviewed as we prepare to implement a new IT system at the end of the year.

We have also recently completed work as part of a corporate complaints pilot. This has resulted in some changes being made to receiving, logging and tracking complaints coming into the service – including monitoring timescales for replies to be sent.
